TWO SUPERVISORS TO BE ELECTED

The special election to fill two JSWCD board of supervisor positions will be held in conjunction with the 71st Annual Meeting. The election, conducted by a representative of the Ohio Soil and Water Conservation Commission, will take place at Saint Florian Hall on October 20, 2014, from 5:45 PM to 6:45 PM. **Voter Eligibility**

Residents or landowners, firms, and corporations that own land or occupy land in Jefferson County and are 18 years of age and older may vote for Jefferson SWCD Supervisor. However, voters representing a corporation, firm LLC or trusts must complete an affidavit form which confirms eligibility and includes designation of a voting representative. This form and the ballot request form are available at the soil and water district office. The request form must be completed prior to casting a ballot.

Casting a Ballot

Eligible voters have three options:

- 1) call or visit the JSWCD office to request an absentee ballot;
- 2) cast a ballot at the district office no later than 4:30 PM, October 20, 2014;
- 3) cast a ballot at the Annual Meeting.



Healthy, fully functioning soil provides an environment that sustains and nourishes plants, soil microbes and beneficial insects. Managing for soil health is one of the easiest and most effective ways for farmers to increase crop productivity and profitability while improving the environment Positive results are often realized immediately and last well into the future.

Soil is made up of air, water, decayed plant residue, organic matter from living and dead organisms, and mineral matter, such as sand, silt, and clay. Increasing soil organic matter typical improves soil health since organic matter affects several critical soil functions, including nutrient cycling and water-holding capacity. Healthy soils are porous and allow air and water to move freely through them.

Here's how to improve soil health:

- Disturb the soil as little as possible
- Grow many different species of plants through rotations and a diverse mixture of cover crops Plant cover crops around harvest to keep living roots growing in the soil for as much of the
- Keep the soil surface covered with residue year round
